The oversized covered rear porch faces prevailing summer breezes and provides expansive water views and stunning sunsets across Palo Pinto lake country. Additional features include a brand new metal roof, integrated alarm security system, and generous parking with two covered spaces plus additional concrete parking. The covered dock is designed for functionality and enjoyment, offering a large boat slip with lift, a second boat slip with lift, cable lift for additional storage, PWC lift with stair access that can be lowered to create a controlled-depth play area. Dockside water faucet for rinsing lake gear, and an upper party or tanning deck. A Pynamite insect misting system services the dock and walkway. This very well-maintained lakefront property combines quality construction, practical amenities, and prime waterfront location.
