Character-filled Westcliff Ranch • engineered hardwoods & tile throughout • stone fireplace • white kitchen with granite • expansive fenced backyard • NO HOA • zoned for Overton Park Elementary! Set beneath a canopy of mature trees in Westcliff, this ranch-style residence blends classic character with thoughtful updates. The painted brick exterior, carriage-style garage doors, welcoming front entry, & warm architectural lines make a strong first impression. Inside, engineered hardwood floors & tile run throughout for a clean, cohesive look with no carpet. Natural light moves easily across the living spaces, where the main living room opens to the kitchen & dining for an effortless everyday flow. At the heart of the home, the kitchen pairs crisp white cabinetry with granite counters, a deep sink, stainless steel appliances, a gas 5-burner range, decorative backsplash, & 2 pantry areas for extra storage. A serving counter opens toward the living room, keeping the space connected for gatherings or quiet nights at home. In addition to the main dining space, the second eating area works well for casual meals or a home office. The stone fireplace anchors the living area with texture & scale, while flanking windows, open shelving, recessed lighting, & glass doors to the patio add charm & function. The primary suite feels tucked away & comfortable, featuring new windows & a large walk-in closet with barn door access. In the primary bath, the oversized walk-in shower with double shower heads adds a spa-like finish with generous counter space. A secondary bath offers distinctive vintage tile character that adds a memorable design note. Out back, the setting opens into an expansive fenced yard shaded by established trees, with a large patio suited for outdoor dining or relaxing evenings. Solar screens add privacy, the sprinkler system covers the full yard, & the Westcliff location, zoned for Overton Park Elementary, places this home in a well-loved Fort Worth setting!
